Thanks to our Candidate Forum Team of Jeanine DeLay, Zoe Behnke, Judy Mich, Barbara Clarke and Nancy Schewe, candidate forums were conducted for the Ann Arbor Mayor's race, Ann Arbor City Council, Ann Arbor District Library, Washtenaw County Commission, Washtenaw Community College, 54<sup>th</sup> State House of Representatives

District and 18<sup>th</sup> State Senate District. The Forums were broadcast live by Community Television Network (CTN) and then rebroadcast many times up until the November 2 election. We are very fortunate to have such wonderful cooperation and support from CTN.

In conjunction with the Ann Arbor District Library, we provided Washtenaw County Voters an opportunity to register on a Saturday in September. Nancy Schewe, Shana Borenstein and Miriam Borenstein registered voters at the Downtown Library and long-

Over 40 League members and special guests, including the Mayor, several City Council members, and our State League President celebrated the League's 90<sup>th</sup> Birthday at Hathaway's Hideaway on October 12. We appreciate League member Mary Hathaway's generosity in making the building, a former polling place for Ward Two, available. It was a perfect location for our celebration. What fun it was to see many long-time members of the League and to welcome new members. Many thanks to Nancy Schewe and her committee for making this event so special. Our League looks forward to many years of serving the Ann Arbor Area community.

This exhibit highlights the Woman Suffrage Movement from 1910-1920, concentrating on 1912 and 1913.

Each room has been designed around a theme. We have three rooms, plus excerpts of the podcasts that can be heard on [lvannarbor.org](http://lvannarbor.org). We will be highlighting Miss Jennie Buell, Miss Estelle Downing, Miss Jessie Phelps, Miss Mary Hinsdale, Mrs. V.C. Vaughan, Mrs. Daniel Quirk, and Mrs. A. C. Plummer.

The women chosen, along side other women and men in Ann Arbor and Ypsilanti, used their talents and expertise to educate the people in Washtenaw County. Who were these people? What role did the University of Michigan, Michigan State Nursing College, and Cleary College play in the suffrage movement? Which college/university presidents supported it? Why were there three Equal Suffrage Associations in the Autumn of 1912? How did the women pay for the expenses and where were the storefronts for their offices? How did they get the vote out? What other organizations were involved in the movement in this county besides

the Equal Suffrage Associations? Wait till you see the hats! And a tea set?

I am looking for docents to help during the exhibit hours. If you would like to learn more about the Woman Suffrage Movement, please volunteer, I will train you.

Jeanine DeLay and I have been working on this exhibit for over a year. We have had people volunteer their services and would like to thank their contributions that made this exhibit possible. The League of Women Voters of the Ann Arbor Area have been working in conjunction with the Washtenaw County Historical Museum on Main Street.

The Grand Opening is on January 16, 2011 from 12:00-4:00. All League members are invited to the opening.

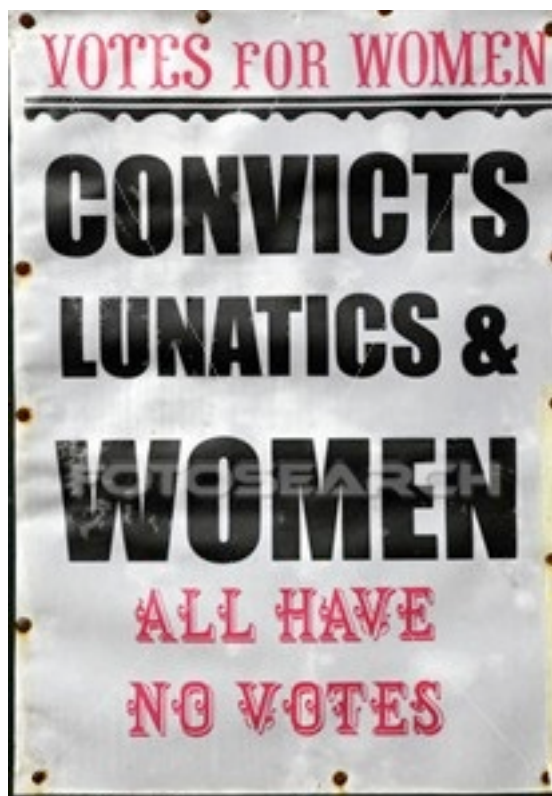
